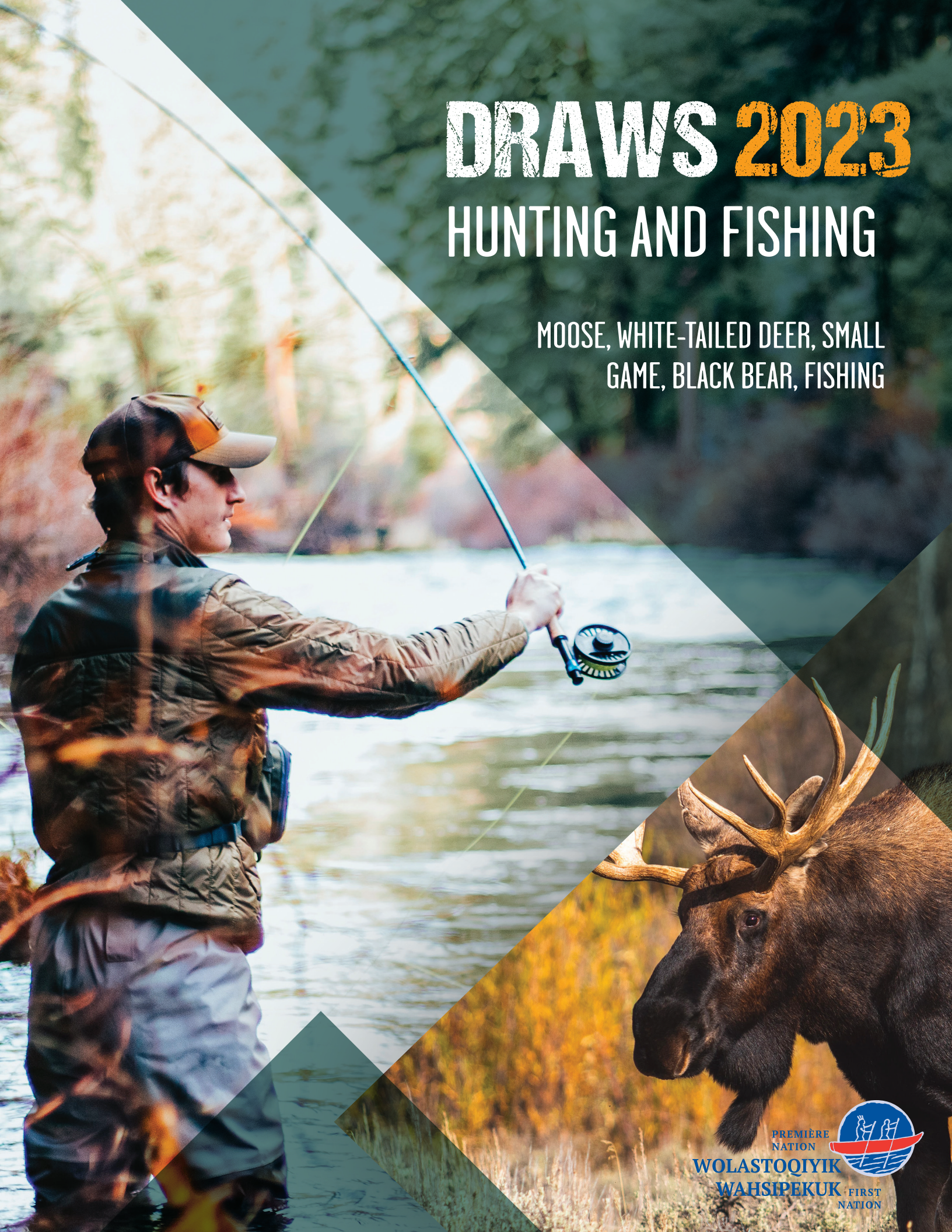

DRAW RULES

1. All participants must have a Wolastoqey membership card recognized by the WWFN Citizenship Code (Stated, Citizen or Associate) and present it if required.
2. To hunt, you must be 12 years of age or older as of September 1, 2023.
3. To hunt, you must hold a provincial firearms, bow or crossbow certificate, or alternatively, a WWFN firearms, bow or crossbow certificate.
4. Each member may participate only once in each draw category whether as a hunter, fisherman or attendant.
5. Complete and send the application forms and the signed commitment contract by email to info@malecites.ca or by mail to 217, rue de la Grève, Cacouna, Qc, G0L 1G0 **before 4:00 p.m. on March 17, 2023**. Please take into account the postal delay.
6. The selection of the stay must be done at the time of the draw; otherwise the group will be put on the list of substitutes. The group leader must be available and prepared to communicate the choice of package for his/her group at the time of the draw. 7. The non-winning groups will form a list of substitutes, the order of priority will be determined by drawing lots.
8. Unless otherwise specified, the composition of a hunting or fishing group may not be changed after the draw has begun. Only the addition of companions or the withdrawal of a fourth hunter will be allowed. If the fourth hunter is removed, that hunter loses the opportunity to join another hunting or fishing party as a hunter or angler. The WWFN must be notified of these changes at least 15 working days prior to the start of the trip.
9. Substitution of a member in a group can be accepted only in exceptional circumstances (death in the immediate family, court summons, unforeseen medical reasons).
10. The group leader must sign the agreement to respect the WWFN hunting and fishing guidelines and vouch for all members of the group, and return it signed with the application form.
11. Accompanying persons allowed: spouses or children of a member of the WWFN may participate as accompanying persons, but may not hunt. On fishing trips, chaperones may only fish under the licence and quota of the WWFN member they are accompanying. The number of accompanying persons may not exceed the number of hunters or anglers at the entrance to the trip.
12. All members of a group registered on the application form (including accompanying persons) and who are winners of a hunting or fishing trip must be present at the registration of their trip. If this rule is not respected, the possibility of participating in the 2024 trips may be revoked for all members of the group entered in the draw.
13. Respect for other hunters, fishermen, users and administrative personnel, both in the WWFN and in the structured territories is essential. No inappropriate behaviour will be tolerated. In the event of an incident, a report will be written and submitted to the competent authorities who will decide on the applicable sanctions.
14. The group leader or individual participant, as the case may be, is required to declare and/or record any kill or harvest when leaving the structured territory for wildlife population monitoring purposes. Failure to do so may result in sanctions for all group members.
15. A new permit for community slaughter is now in effect. No community slaughter will be accepted without prior authorization from the WWFN.
16. In order to avoid incidents, hunters must respect the designated areas and hunting hours at all times, even during the November hunt.

17. Any serious breach of the rules by a member of a group may result in sanctions up to and including the exclusion of all members of the group entered in the draw.
18. **All participants must sign the draw application form, which certifies that they are all aware of the rules in effect.**

MOOSE RIMOUSKI WILDLIFE RESERVE

- Packages of 4 or 5 days of hunting in an exclusive managed area for groups of 4 hunters, lodging in a cabin included.
- Possibility to shoot 1 moose per group of 4 hunters. Obligation to affix 2 transport coupons on the animal.
- Possibility of hunting only one male white-tailed deer per moose hunting trip (3 antlerless deer permits will be awarded by random draw for three moose hunting groups).

MOOSE DOUBLE GROUP RIMOUSKI WILDLIFE RESERVE

- Groups of 6, 7 or 8 hunters.
- For the whole double group, two (2) moose can be taken during this stay.

MOOSE DUCHÉNIER WILDLIFE RESERVE

- Packages of 4 or 5 days of hunting in an exclusive managed area for groups of 4 hunters, lodging in a cabin included.
- Possibility to shoot 1 moose per group of 4 hunters. Obligation to affix 2 transport coupons on the animal.

WHITE-TAILED DEER DUCHÉNIER WILDLIFE RESERVE

- 4-day hunting packages in an exclusive managed area, including cabin accommodations for groups of at least 3 hunters.
- Possibility to shoot one antlered animal per hunter.
- A female permit will be issued for the group.

SMALL GAME RIMOUSKI-DUCHÉNIER WILDLIFE RESERVE

- 2 or 3 day hunting packages for groups of a minimum of 3 hunters. The maximum number of hunters is established according to the capacity of the cabin connected to the hunting sector.

BLACK BEAR RIMOUSKI AND DUCHÉNIER WILDLIFE RESERVES

- Individual or group hunting in exclusive area, without accommodation.
- The hunter registered on the registration form and who has won a stay must be present at each hunt (baiting not included). He may be accompanied by a hunter who must be registered at the time of confirmation.

FISHING RIMOUSKI AND DUCHÉNIER WILDLIFE RESERVES

- 2–3 day fishing packages for groups of a minimum of 3 WWFN member anglers on exclusive lakes, cottage accommodations included. Boats provided (outboard motor not included).
- Children of Wolastoqiyik fishermen under 18 years of age, who do not hold a membership card, may fish under their parents' licences without having to pay the fishing fee. If they wish to fish under their own licence, they will have to pay the fishing fee.

COMMUNITY FISHING ACTIVITY

- Possibility of participating in fishing trips on exclusive lakes with boats provided (outboard motor not included).
- Lodging being limited, the allocation of cottages will be done by drawing lots.

ADDITIONAL INFORMATION

- The group leader is responsible for the behaviour and damages that may be caused by the accompanying persons during the stay.
- Accommodations are available for seniors and people with special needs (e.g., mobility impairment).
- **It is your responsibility to make sure that your telephone numbers, postal and email addresses are correctly entered so that we can reach you easily and quickly. You must be reachable at the time of the draw, otherwise the choice of the group can only be made once the draw is over, if there are still choices available.**

- I confirm that I am aware of the specific rules for access to the packages and I undertake to respect them.
- I am responsible for the behaviour and actions of the other members of my group and I agree to communicate the necessary information to them so that they comply with them.

WWFN Package Rules

- All hunters and anglers must have a valid licence issued by the WWFN when they arrive at their stay and carry it with them when conducting their activities.
- Unless otherwise specified, the composition of a winning hunting or fishing party may not be changed after the group is selected. Only the addition of companions or the removal of a fourth hunter will be permitted. If the fourth hunter is removed, that hunter loses the opportunity to join another hunting or fishing group as a hunter or angler.
- Substitution of a group member can be accepted only in exceptional circumstances (death in the immediate family, court summons, unforeseen medical reasons).
- In the event of cancellation or withdrawal, the package will be offered to the substitutes in accordance with the administrative procedure for substitution.
- All group members, including chaperones, must be present during the trip and all of them, without exception, must sign an attendance register when they enter the trip.
- The group leader or individual participant, as the case may be, is required to declare and/or record any kill or harvest upon leaving the structured territory for wildlife population monitoring purposes. Failure to do so may result in sanctions for all group members.
- A new permit for community slaughter is now in effect. No community slaughter without prior authorization from the WWFN will be accepted.
- In order to avoid incidents, hunters must respect the designated areas and hunting hours at all times, even during the November hunt.
- Respect for other hunters, anglers, users and administrative staff, both in the WWFN and in the structured territories is paramount. No inappropriate behaviour will be tolerated. In the event of an incident, a report will be written and submitted to the appropriate authorities who will decide on the applicable sanctions.
- Any serious breach of the rules by a member of a group may result in sanctions, up to and including the exclusion of all group members entered in the draw.

Procedure by Internet:

Please note that Internet orders will be processed within 48 hours and are subject to normal mailing times

- 1) Go to wolastoqiyikwahsipekuk.ca.
- 2) At the top of the page, select “**Members’ Area.**”
- 3) Fill out the information requested to log in to the portal.
- 4) Select the “**Edit my profile**” button. This will take you to your profile.
- 5) Verify the contact information that automatically appears in the “**My Profile**” box.
 1. If the information is correct, return to the dashboard.
 2. If the information is incorrect, make the changes in the side-by-side table and click the “**Save Changes**” button. Then return to the dashboard.
- 6) Select the “**My permits**” button.
- 7) Read the general information for each permit and select the permit(s) you wish to apply for. Once you have made your choice, click on the “**Apply**” button.
- 8) Confirm your order by checking the shipping information. Proceed to the payment via credit card by filling in the required information in the “**Payment Method**” table. To finish, click on the “**Place Order**” button.
- 9) At the end of the transaction, the following window will appear: “Order sent successfully.” If you do not see the confirmation window, contact the First Nation at 1-888-399-2393 or 418-860-2393.
- 10) Immediately after the “order successfully sent” window appears, you will receive an order confirmation at your email address.
