

### Non-quota sector:

1. Please note that the non-quota sectors of the Mitis-Mistigouèche and Rimouski rivers are accessible to the members of the WWFN between July 1st and September 30, 2023. It is necessary to inform the WWFN traditional activities officer 48 hours before the beginning of the fishing day at 418-860-2393 ext. 215 or by email at [info@malecites.ca](mailto:info@malecites.ca).

### Quota sector:

To fish in the quota areas, you have two options:

1. Register for the draw before April 21, 2023, by completing and sending your form by mail or email to [info@malecites.ca](mailto:info@malecites.ca) **before 4:00 p.m. on April 21, 2023, at the Cacouna administrative office.** Please take into consideration the postal delays.

OR

2. Register 72 hours in advance with the agent for the enhancement of traditional activities with the desired pool.

### To fish for salmon:

1. You must have a Wolastoqey membership card recognized by the WWFN citizenship code (status, citizen or associate) and be able to provide it if required.
2. You must be 12 years of age or older as of April 1, 2023.
3. You must have a WWFN salmon fishing licence.
4. When registering at the river ZECS reception posts, the Wolastoqey membership card and the confirmation of the stay provided by the WWFN are mandatory without which we cannot guarantee access to the territories. For accompanying spouses or children, without a Wolastoqey membership card, please provide an ID that proves you are the spouse or child of a Wolastoqey fisherman in the group you are accompanying. Ex: driver's license (same address), birth certificate, etc.
5. Registration on the salmon ZECS must be done in a respectful manner and according to the same process as all other fishermen in order to preserve harmony, your safety and that of other users. This obligation is all the more important since it allows us to offer a positive image of the members of the WWFN. In the event of a substantiated complaint regarding disrespectful behaviour by a Wolastoqey member towards an employee or other user of one of the rivers, please be advised that sanctions up to and including cancellation of river access benefits may be applied.
6. Each salmon caught on the rivers will have to be registered at the reception post and the fisherman is responsible for informing the WWFN traditional activities officer at 418-860-2393 ext. 215 as soon as possible after the catch.

## Procedure by Internet:

Please note that Internet orders will be processed within 48 hours and are subject to normal mailing times

- 1) Go to [wolastoqiyikwahsipekuk.ca](http://wolastoqiyikwahsipekuk.ca).
- 2) At the top of the page, select “**Members’ Area.**”
- 3) Fill out the information requested to log in to the portal.
- 4) Select the “**Edit my profile**” button. This will take you to your profile.
- 5) Verify the contact information that automatically appears in the “**My Profile**” box.
  1. If the information is correct, return to the dashboard.
  2. If the information is incorrect, make the changes in the side-by-side table and click the “**Save Changes**” button. Then return to the dashboard.
- 6) Select the “**My permits**” button.
- 7) Read the general information for each permit and select the permit(s) you wish to apply for. Once you have made your choice, click on the “**Apply**” button.
- 8) Confirm your order by checking the shipping information. Proceed to the payment via credit card by filling in the required information in the “**Payment Method**” table. To finish, click on the “**Place Order**” button.
- 9) At the end of the transaction, the following window will appear: “Order sent successfully.” If you do not see the confirmation window, contact the First Nation at 1-888-399-2393 or 418-860-2393.
- 10) Immediately after the “order successfully sent” window appears, you will receive an order confirmation at your email address.
